About AWS

Ambulance Wish (Singapore) Ltd is a registered charity with an Institution of Public Character (IPC) status that celebrates the lives of terminally ill patients in Singapore. Our work supports them and their loved ones through the simple but deeply meaningful act of wishgranting. By helping to fulfil these wishes, Ambulance Wish Singapore (AWS) wants to transform the end-of-life experience for patients with a limited prognosis of less than 12 months, giving them and their families a measure of joy, peace and comfort. The work of AWS is an extension of the provision of care for the dying that goes beyond the walls of hospitals and hospices, to impact homes and hearts. To date, with the support of 380 volunteers, we have fulfilled more than 200 wishes.

Our Mission

To create positive end-of-life experiences for terminally ill patients through the fulfilment of their final wishes.

Our Vision

To transform the end-of-life experience of terminally ill patients and their loved ones, beyond basic palliative care services.

Chairman's Message

As we cross another year, Ambulance Wish Singapore has grown a year older. A significant milestone in 2023 was when we obtained our status as an Institution of Public Character (IPC). With the IPC we hope to do more and to make more of an impact through our wish granting work.

From our humble beginnings in 2019, we have since fulfilled more than 200 wishes. We endured the covid years like everyone and have emerged stronger.

A crucial aspect of our lives that we often overlook is the end of life.

We all have our own unique journey, and how we approach the final stages of our life.

Quality of life at the end of life is not just about medical care; it's about living with dignity, comfort, and support. It's about having our physical, emotional, and spiritual needs met. It's about being surrounded by loved ones and experiencing joy, love, and closure.

Ambulance Wish Singapore seeks to fulfil lives by our wish granting. It is not only those that leave but those that continue to live that benefit from the wishes granted.

We seek to bring to our clients in the final days of their life, purpose, love, peace and closure.

The work that we do varies from wish to wish and we try to accommodate every wish requested with the resources available and the constraints that we face.

Our work is dependent on the volunteers that are our hands, legs and face. They are the front facing people that go out to grant wishes, meet sponsors and share our mission.

Chairman's Message

As at end of 2023 we have 380 volunteers across all segments of society, races and religions. All sharing a common vision of fulfilling last wishes. To all of you I extend my heartfelt thanks.

Our work is also dependent on our sponsors and supporters who provide the financial and non-financial resources that make our work possible.

In 2023, we had our second edition of Cycle of Peace where we raised \$117,423. We also had the concert "Solace" which was co-organised by Project Gift of Song and NTU Piano Ensemble, where we raised \$56,777. These events together with our other online and offline campaigns would not have been possible without the support of our sponsors, supporters and friends. To all of you please accept my gratitude.

Finally our work is only possible with advocates that believe in bringing meaning to one's end of life journey. As we look back at the years from our beginnings, we have made significant strides but the coming years will prove more challenging as we seek to create a greater impact with the work we do and we therefore seek the continued support of our various stakeholders to continue this journey with us.

Finally a word of thanks to one of our founding board member Prof Koo Wen Hsin who left the board on 21 June 2023. Thank you for your guidance, counsel and direction in our early years.



Achieving IPC Status

One of our biggest corporate milestones was reached in October 2023 when we become an approved Institution of a Public Character (IPC) governed under Chapter 37, Section 40C of the Charities Act.

This means that eligible donations will enjoy tax deductions of 2.5 times the qualifying donation amount, which incentivises people to donate as they can reduce their taxable income. IPC status also boosts public trust and confidence in AWS.

Celebrating our 4th anniversary

Yes, we turned four in 2023! Every "birthday" is a celebration of how we grow bigger, bring more joy and create more impact each year with our wonderful community of volunteers and supportive stakeholders. To date, we have fulfilled more than 160 wishes with the help of 350 volunteers.

As part of the celebration on 27 May 2023, we appointed our first AWS ambassador - Vincent Ng (翁清海), a Singaporean actor and martial arts practitioner. In a Facebook post, he wrote, "I was instantly drawn to (the AWS) mission - to create memorable end-of-life experiences for terminally ill patients through the fulfilment of their final wishes. To be able to bring some cheer, comfort and closure to someone at their end stage of life through small but deeply meaningful acts of wish-granting is truly meaningful to me. I am honoured to be part of the AWS family as their first ambassador."

Cycle of Peace

The second edition of our annual fundraiser, Cycle of Peace, was held between 27 May to 31 July 2023. We raised \$117,423 with the support of cyclists who covered a distance of nearly 35,000km, donors and partners including organisations like Aquinas Law Alliance LLP and Schroder Investment Management (Singapore) Ltd. The funds raised will enable us to reach out to more patients and bring them joy in the last chapter of their life.

A unique addition to the virtual cycling charity drive was "5 Wishes - A Celebration of Life", where cyclists visited five venues (Botanic Gardens, Marina Barrage, Gardens by the Bay, Sentosa, Singapore Zoo) where past AWS wishes had taken place to collect e-Badges to win a prize.



Management and Avoidance of Conflict of Interest Policy

The charity has a documented policy in place to manage and prevent conflicts of interest among directors, staff and volunteers. Each Board member is obligated to disclose any conflicts of interest to the charity annually at the beginning of their term or as soon as such conflict or possibility of such conflict arises.

As stated in the Organisation's By-laws, all Board members are prohibited from receiving any form of compensation except for reimbursement of reasonable expenses related to fulfilling wish granting expenses. Upon employment and on an annual basis, all employees are required to disclose any conflicts of interest. Furthermore, staff members are not involved in determining their own compensation. In order to ensure transparency, any conflicts of interest related to contracts with vendors, affiliations with other organisations, joint ventures, recruitment, and remuneration of staff with close relationships must be fully disclosed. Individuals with conflicts of interest are excluded from participating in discussions and approvals regarding such transactions.

Reserve Management

The charity relies on its reserves to ensure financial stability and support the growth of its activities. The Board intends to maintain reserves at a level that adequately meets the organization's operational requirements. Regular assessments of the reserves are conducted to ensure they align with the ongoing obligations of the charity.
